**Signing Up** – We accept secure credit/debit card payments our website at [www.elliottfarm.org/csa](http://www.elliottfarm.org/csa). We also accept cash or check. By becoming a member of our CSA, you hereby give Elliot Farm permission to use your name in CSA-related social media posts. By becoming a member of our CSA, you are agreeing to open and read emails as soon as you see them since the information could be time sensitive.

**CSA “Harvest Card”** – Our CSA is available in the form of a Harvest Card (instead of weekly shares), which members can use, like a debit card, throughout the season to purchase any items in our U-Pick fields & Farm Stand. Members receive a 10% increased value on their Harvest Card. Your Harvest Card is required to check-out at the farm stand. Members may pick up their Harvest Card at Elliot Farm anytime during regular business hours once we open in May.

- **Terms:** Harvest Cards are redeemable for merchandise only. The value on your Harvest Card must be used within the year it is purchased; it does not roll over from year to year. Card value cannot be redeemed for cash. Wholesale and gift card purchasing is excluded. The Harvest Card is not a credit/debit card and has no implied warranties. Elliot Farm is not responsible for lost, stolen or damaged cards or any unauthorized card use. If you misplace your Harvest Card, please contact Dee Elliot at (774) 419-5756 or [elliottfarmcsa@gmail.com](mailto:elliottfarmcsa@gmail.com) immediately, and she will issue a replacement card for a fee of \$5.00.
